- Evaluate delivery & pickup destinations and execute most efficient route.

- Confer and correspond with NPL personnel to rectify problems with deliveries/pickups, such as damages, shortages, and nonconformance to specifications.
- Load and unload delivery trucks using forklift or pallet jack, following all safety standards.

- Assist in managing customer returnable packaging programs
- Ensure accuracy of shipment through verification of Bill of Lading.
- Document preventive maintenance and daily equipment safety checks in the vehicle logbook.
- Coordinate required maintenance with Nicolet approved vendors.
- Reflect a positive NPI image through communication with receiving personnel at customer location when delivering goods.
